PROCEDURE: SOFTWARE/APPLICATIONS AND EXTENSIONS REQUEST CRITERIA

BACKGROUND

The Division recognizes the value of new software programs and Chrome(book) application/extension programs that have a positive contribution to both the instructional and learning processes. To help maintain a quality education program the school division requires that only software and applications/extensions vetted for curriculum relevance be purchased/approved and installed on the Christ the Teacher School Division computers by the I.T. Department.

CRITERIA

- 1. All computer software and applications (including extensions) in use are purchased by the school division under academic licenses. Software and applications/extensions must be used legally in accordance with relevant licensing and copyright agreements. Software and applications that are not purchased nor authorized by the Christ the Teacher Catholic School Division cannot be used in any capacity within the school division. Free software and applications still require division authorization.
- 2. Only system approved standard software and applications/extensions installed by the IT Department are allowed to run on school division networks.
- 3. All software and application/extension requests will be forwarded to the school principal. Upon approval from the school principal, all software and application/extension requests will be vetted by the Superintendent of Education for curriculum relevance and then reviewed by IT to ensure appropriate IT criteria are established.
- 4. All requests for software and applications/extensions that have had previous approval will only need to be approved by the school principal. The school principal will then request support from IT for assistance and installation. Refer to Appendix A for software requests and Appendix B for Chrome(book) Application/Extension requests.
- 5. Chrome and Chromebook applications/extensions that have been previously approved can be found in the private web store at http://chrome.google.com/webstore. Login using your @cttcsed.ca account. Then click on CTTCS-Authorized.
